



Tuition Fee Reduction Programme (TFRP) 2018/2019

Munich International School e.V. (MIS) was established in 1966 to serve Munich's international community and interested German families. MIS provides an international, co-educational, English language learning environment for students aged 4 -18. High academic standards, a diverse curriculum and a clear focus on the moral, intellectual, physical and emotional development of students are central to the MIS experience. As a supplementary school (Ergaenzungsschule) and as an alternative school (Ersatzschule) MIS is mainly financed by tuition fees paid by families or the employers of families who are sending their children to MIS. Munich International School e.V., is a non-profit organization and as such, all revenues are devoted entirely to ensuring that the School fulfills its educational mission and objectives.

In consideration of the statutory purpose of the School, MIS offers a Tuition Fee Reduction Programme (TFRP). Its purpose is to ensure international and social diversity and to make Munich International School e.V. accessible to students with the interest and need for an international education regardless of economic status.

Tuition Fee Reduction Programme Eligibility

Munich International School e.V. is now accepting applications for the TFRP from current students and new applicants in Grades 1-12 for the School Year 2018/2019.

To be eligible for consideration for a tuition fee reduction a family must have been resident in Germany for at least 6 months and have not have any access to alternative financial support through corporate or their own company, government or any other means of sponsorship.

In addition, the student's need for a tuition fee reduction must be established through the completion of a Tuition Fee Reduction Programme Application, which requires timely submission of detailed family financial information. The school reserves the right to request a certified translation of required financial information.

If eligible, the consideration for tuition fee reduction is guided by the following parameters and requirements:

1. All financial information shared with the school is confidential, with procedures in alignment to the German Data Protection Act.
2. All required information must be submitted to the school by May 1 for returning students and by new students, at the time they are completing the admission process prior to May 15.
3. To allow resources to be broadly shared within the community, a maximum of two students per family will be able to apply for a tuition fee reduction.
4. The student, prior to his or her consideration for a tuition fee reduction, must meet the generally applicable admission criteria, provide evidence of a strong academic standing and show the interest and ability to benefit from our international school program of studies.
5. The family is internationally oriented and there is a clear student need for, or demonstrable benefit to, an international education program.
6. The family is willing and able to play an active role in the support of the student's participation in our English language educational community.
7. The family and student are willing, interested and able to pursue further study opportunities to build on the Munich International School experience.
8. The numbers 5-7 above do not only apply to TFRP applicants but also to all students in general.

Tuition fee reductions are granted for one year only and must be applied for annually. The TFRP does not confer an enforceable claim to receive a reduction even if all criteria are met.



Selection Process for Tuition Fee Reduction Programme (TFRP) Participants

A tuition fee reduction committee will determine TFRP participants. All TFRP applications must be submitted to the Admissions Office.

Once admission eligibility has been established, consideration for available funding for a tuition fee reduction will be prioritized using the following criteria:

1. Students nearing graduation.
2. Students from a single-parent household.
3. Students from families with more than two children enrolled in the school.
4. All other students will be processed in the order of the date the application was received.

Annual TRFP Fee Structure

For an approved TRFP application, the annual tuition fee payable under the TRFP is based on his or her family's gross annual income and the assets. Gross income includes all positive earnings regardless of the origin or if the earnings are taxable. Child benefits/family allowances are also considered income. Negative income will not be deducted from positive income.

Please complete the Tuition Fee Reduction Programme (TFRP) Application and return it with the documentation requested to the MIS Admissions Office. The deadline for submission of the application **including all required documentation** is May 1, 2018 for returning students, and, for new students, at the time they are completing the admission process and no later than May 15, 2018. Please note that TFRP applications received after those dates will not be eligible for consideration.

To qualify for consideration for TFRP funding, an applicant must either be a current MIS student or have been offered a place by an admission application on file with the Admissions Office. Please be assured that all information related to TFRP applications is held in strict confidence.

Any applications that are incomplete by the application deadline will not be considered. Submission of a TFRP application does not automatically guarantee a tuition fee reduction. Decisions on TFRP participants are confidential and will not be discussed. All decisions are final and cannot be appealed. Tuition fee reductions are granted for one year only and must be applied for annually. The TFRP does not confer an enforceable claim to receive a reduction, even if all criteria are met.

The reduction amount only applies to tuition fees and does not include other fees such as the application fee, entrance fee, IT fee etc.
